

NOMINATION OF LAW ENFORCEMENT OFFICER TO PARTICIPATE IN THE POLICE EXECUTIVE FELLOWSHIP PROGRAM OF THE FEDERAL BUREAU OF INVESTIGATION

I realize that the Police Executive Fellowship Program is a six-month program which provides a professional opportunity for state and local law enforcement managers to serve at FBI Headquarters in programs that will assist FBI operations, and subsequently benefit their home agency upon the conclusion of their assignment. Specifically, I understand the nominee meets the following minimum requirements:

1. A regular full-time officer of a duly constituted law enforcement agency of a municipality, county, or state, having at least five years of substantially continuous such experience;
2. Attained the equivalent rank of lieutenant or above;
3. Is of excellent character and embodies a reputation of professional integrity;
4. Agrees to undergo a full background investigation;
5. Agrees to undergo a counterintelligence polygraph examination; and
6. Agrees to remain in law enforcement a minimum of three years upon completion of the Police Executive Fellowship Program.

The Executive Fellow assignments are authorized under the Intergovernmental Personnel Act (IPA) 5 U.S.C. Sections 3371 through 3375 and regulated under the Code of Federal Regulations (C.F.R.). part 5, chapter 334. Individuals **excluded** from participation in the PEFPP include: federal, state or local government employees serving under non-career, excepted service, noncompetitive, time-limited, temporary or term appointments; elected federal, state or local officials; and members of the uniformed military services.

When a vacancy exists for which the Executive's application can be considered, I authorize the FBI to make a complete and thorough investigation of the nominee to confirm his/her suitability as a candidate. To assist in this regard, attached is the nominee's executed application. I have been assured by the nominee that he/she will remain in law enforcement for a minimum of 3 years upon completion of the Police Executive Fellowship Program.
